# Benefits of Accurate Lists

- Helps reduce costs
- Minimizes congestion or wait times at the polls
- Reduces the need to complete additional forms at the polls
- Helps instill confidence in voters about the integrity of elections



# Current Challenges

- Keeping pace with increasing movement of voters to maintain accuracy of voter rolls
- Meeting expectations of voters
- Determining duplications, moves
- Need for Newer Technologies and Services
- Cost of upgrading list maintenance processes to latest technologies and available data



# Ongoing Problem

- **Ford Carter Report (2001)** Highlighted the developing problem of inaccurate voter lists and the need for an accurate voter registration list of eligible citizens qualified to vote
- **Carter Baker Commission (2005)** States need to effectively maintain and update their voter registration lists by having complete, accurate and valid lists of citizens eligible to vote
- **Presidential Commission on Election Administration (2014)** Accurate voter lists are essential to the management of elections and keeping track is a Herculean task

# By the Numbers

According to the EAC's Election Administration and Voting Survey, between 2020 and 2022 states reported **19,260,000** records processed from voter registration lists through NVRA



# EAC Experian Pilot Research Program

# Orange County, California

- OC has used this data for over 10 years; provided ability to reach voters who moved outside county because nationwide reach of database.
- OC saved \$60,000 in future mailings and administrative costs with that one review.
- Over four data runs with Experian, and over four federal election cycles, Orange County sent 401,000 voter records and generated 74,100 voter-confirmed information updates.

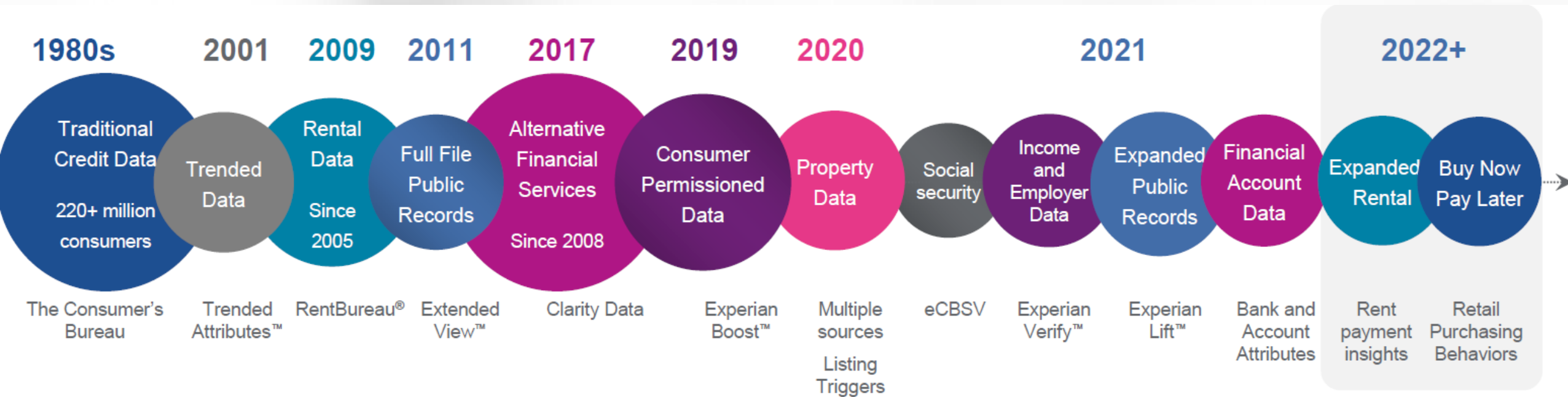


# Experian Pilot Program

- Purpose was to gauge the effectiveness of using commercial data for best address and list maintenance procedures.
- Experian can provide best or potentially new addresses, phone numbers and email addresses for reaching out to voters.
- Use of SSN not required or needed.

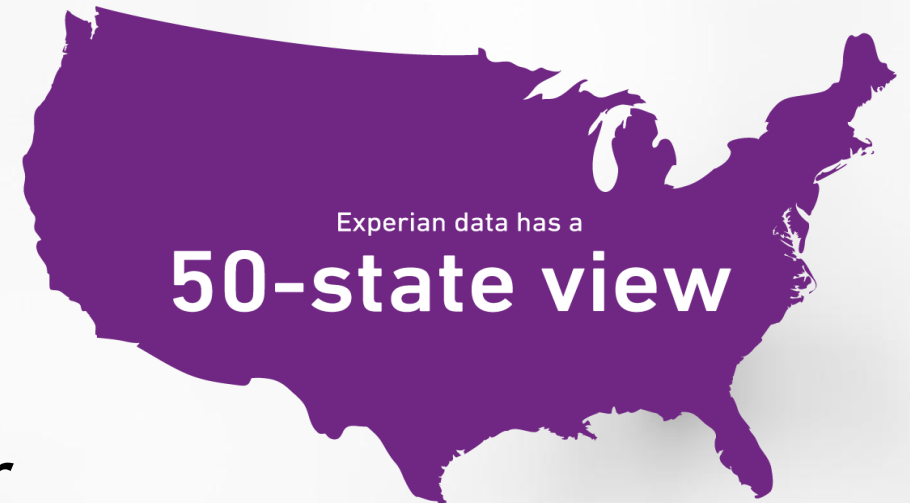


# Sources of Data Utilized



# Parameters of Experian Pilot

- 5 local jurisdictions and 6 states participated
- Entities ran batches that best met their needs
- Training tutorials and additional follow up support were provided for each entity onboarded
- EAC covered costs



# Mechanics



- Participating jurisdictions submitted their data directly to Experian.
- The data submitted to Experian included the voter's name, address (street, apartment/unit number, if applicable, city, state, and zip code), and, where permissible, the voter's birthdate.
- Experian also provided information about whether the new address found for a voter derived from the USPS's NCOA data for some jurisdictions.

# Top Level Numbers from Pilot



- 11 million addresses submitted
- 74% of those addresses were verified as being the most up-to-date
- 11% could not be matched
- 15% generated a new updated address

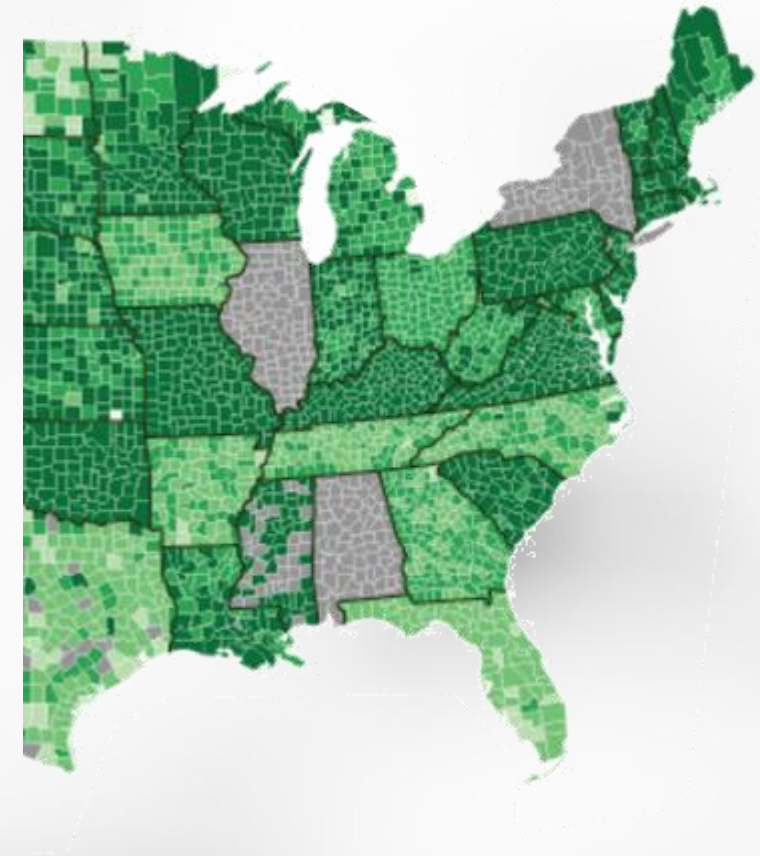
# Initial Pilot Findings

- Voter roll address and Experian address differed by 12%. This 12% correlates with the 14% mobility rate of voters each year.
- Results were the same if not better than what was produced with National Change of Address (NCOA).
- More refinement of information needed to make more user friendly for elections officials.
- 67% of the data had a “touchpoint” within the past month and 82% had a “touchpoint” within the past 6 months.

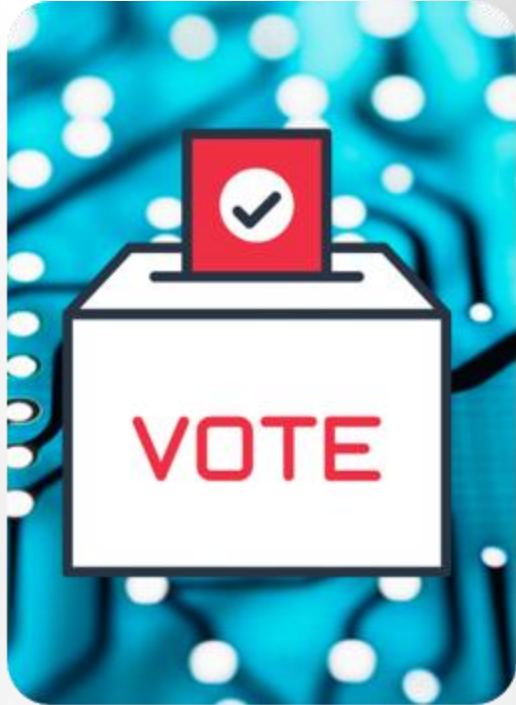


# State Feedback

- Broader information was received back compared to other address databases, such as NCOA.
- Processes may have to be altered to ease integration into current voter registration systems.
- More flexibility is needed in navigating the data received back.

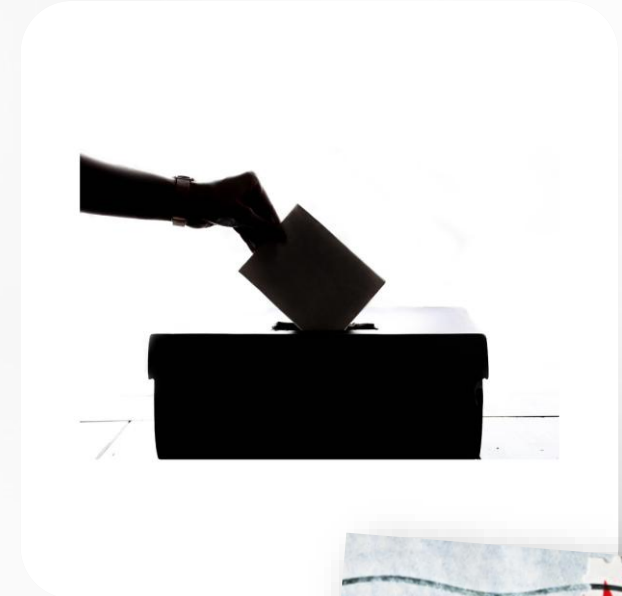

# Ongoing EAC Assistance

- Section 10 of the NVRA authorizes the federal government to provide assistance to states to implement the Act's provisions effectively
- Continued research and support for list accuracy and security.
- Bipartisan approach to clearinghouse of information
- Subsidizing regular list maintenance as a benefit to officials and voters by easing the burden
